THE SOUTHEASTERN EDUCATION CENTER WORKS WITH STUDENTS WHO HAVE BEEN CHALLENGED IN TRADITIONAL SCHOOL SETTINGS AND ARE IN NEED OF INDIVIDUALIZED EDUCATIONAL SUPPORT. OUR TRAUMA-INFORMED APPROACH TO EDUCATION PROVIDES ACCESS TO MENTAL HEALTH AND WRAPAROUND SERVICES WITH THE GOAL OF SCHOLARS RETURNING TO THEIR SCHOOL OF ORIGIN.

YOUTH SHELTER - OUR SHELTER IS OPEN 365 DAYS A YEAR AND PROVIDES EMERGENCY SHORT-TERM SHELTER FOR ADOLESCENTS AGED 11-17, PLUS CRISIS COUNSELING SERVICES FOR YOUTH AGED 18-21. WE OPERATE ONE OF ONLY TWO STATE-LICENSED YOUTH SHELTERS SERVING MILWAUKEE, REPRESENTING HALF OF THE AVAILABLE BEDS IN THE CITY FOR YOUTH. DURING AND AFTER THEIR SHELTER STAY, WE OFFER YOUTH INTENSIVE COUNSELING, CASE MANAGEMENT AND BASIC NEEDS SERVICES THAT HELP THEM MAINTAIN SAFETY AND STABILITY.

ONCE HOUSED, WE OFFER SUPPORT TO YOUTH AS THEY WORK TOWARDS STABILITY, MENTAL WELL-BEING, EDUCATION, EMPLOYMENT AND OTHER PERSONAL GOALS. OUR PROGRAMS OFFER SUPPORTED HOUSING SERVICES THAT ARE INDIVIDUALIZED TO THE NEEDS OF EACH YOUNG PERSON.
